An update was provided on recent events that were well attended. The projector has been purchased and used for the Owl Talk (this needs adding to the assets list). No events in January but there will be a tea/coffee event in February.

A parishioner has verbally raised their unhappiness over the recent road closure. Whilst this was minuted and added to the website as 'News' it was agreed that such matters can be posted on the Church noticeboard and will be discussed at the forthcoming meeting to discuss communications.

## **2025/101 - 8. To discuss and decide upon any course of action in relation to the Surveyor's Quarry**

The Parish Council have assumed ownership of the Surveyor's Quarry in accordance with the Enclosure Award, having established that the land was not owned and following advice from Sheffield City Council Legal Team a number of years ago. A sign was erected to reflect this with the intention to register ownership at a future point. Recent events have caused concern and the need to establish ownership.

**RESOLVED: The Clerk to carry out a search with HM Land Registry via the Parish Council solicitor.**
